The ABM Board of Directors, under the rule making authority granted by the CC&R's and Bylaws, has adopted the information stated herein. The Rules and Regulations of the Association are not limited to those appearing here and are subject to change. Members are subject to those changes, regardless of the date of signing this Agreement.

1. The Legal Owner(s) or Legal Designate is responsible for the completion of applicable forms and provisions of the required information. It is the responsibility of the Legal Owner(s) or Legal Designate to ensure that all required fees and assessments are paid when due.
2. To ensure the accuracy of our records, all non-owner occupied properties should be registered with ABM within (10) days of the lease.* This program and its services are voluntary.
3. All Rules and Regulations and CC&R's must be followed and abided by at all times. Legal Owner(s) or Legal Designate is responsible for any legal penalties levied against the property as a result of conduct by tenants and/or occupants, and/or including guests, for violations of any written Rules and Regulations, Architectural Guidelines, Policies and CC&R's.
4. The Legal Owner(s) or Legal Designate will inform all prospective tenants/occupants that the property is located within a Homeowner Association prior to executing a lease or allowing occupancy. Under the Non-Owner Occupied Program, we will provide all necessary community documents to your tenant, by mail, in the form of a *Welcome Packet* each time we are notified of a new tenant.
5. With regard to age-restricted properties, Legal Owner(s) or Legal Designate will inform all prospective tenants/occupants of the minimum age requirement of the property, and ensure all occupants meet the requirements as stated in the applicable covenants, prior to executing a lease or allowing occupancy.
